## PET RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT

THIS AGREEMENT INCLUDES A RELEASE OF LIABILITY AND WAIVER OF LEGAL RIGHTS AND DEPRIVES YOU THE RIGHT TO SUE THE OWNERS OF PETLAND NORWIN, THEIR FRANCHISOR, OR ANY RELATED PARTIES. DO NOT SIGN THIS AGREEMENT UNLESS YOU HAVE READ AND UNDERSTAND IT IN ITS ENTIRETY. SEEK THE ADVICE OF LEGAL COUNSEL IF YOU ARE UNSURE OF ITS EFFECT.

- 1. All Dogs Participating in Boarding and/or Daycare must:
  - Be current on Rabies, Distemper, and Parvo Vaccinations
  - Be current on Bordetella vaccinations within 6 months of stay.
  - Be current on any licensing that may be required by the state or municipality
  - Be in apparent good health and free of fleas and ticks
  - be spayed/neutered if 6 months of age or older (daycare requirement)
  - be at least 16 weeks of age (daycare requirement)
  - be non-aggressive towards other dogs and people (daycare requirement)
  - not be protective of toys (daycare requirement)
  - Be current on Feline Vaccinations (cat boarding requirement)
- 2. Your pet will be fed per your instructions provided above, if at anytime during your pets stay the food supplied by you is not sufficient, Petland Norwin will attempt to contact you to purchase more food. If Petland is unsuccessful in reaching you, Petland Norwin will provide your pet with Nutrisource Chicken and Rice Formula.
- 3.Petland Norwin will not be liable for any lost, stolen, or damaged property belonging to you or your pet.
- 4. Prior to being eligible for doggy daycare, your pet must pass a socialization test provided free of charge by Petland Norwin. If your pet exhibits aggressive or unruly behavior, your pet may be separated from other dogs, and asked not to return to daycare. These decisions are made at the sole discretion of Petland Norwin.
- 5. No pet may be left at Petland Norwin's facility after the scheduled pickup time without communication from you. If your pet is left without communication for a period of 7 days past scheduled pickup time, your pet will be deemed abandoned. After being deemed abandoned, Petland Norwin will become the pet's legal owner and guardian. Petland Norwin will have full rights to re-home, or relinquish your pet to a shelter of its choice. If you abandon your pet at Petland Norwin, you will be unable to retrieve possession of your pet, and will have no recourse against Petland Norwin.
- 6. You are responsible to disclose, on a continuing basis, any medical concerns or behavioral concerns you may have for your pet after the initial application is submitted.
- 7. ACCEPTANCE AND ACKNOWLEDGMENT OF RISK. You fully understand that there are inherent risks involved with interactions between humans and dogs, as well as interactions between dogs and dogs. These interactions may result in property damage or bodily injury, including but not limited to permanent disability, sickness or death to human or dog. You fully accept and assume all risks and responsibility for all risks, including without limitation all losses, costs, and damages incurred as a result of your dogs participation at daycare, including veterinarian expenses incurred on behalf of, or caused by your pet. Sickness includes any illness not limited to bordetella (Kennel Cough), Bloat, or any other form of contagious disease.
- 8. Petland Norwin will have the right to obtain medical treatment for your pet at its sole discretion. If it appears that your pet is ill, injured, or exhibits any behavior that would suggest that your pet may need medical treatment, Petland Norwin will attempt to seek treatment at the veterinarian listed in the pet application. Petland Norwin retains the right to seek medical attention at St. Francis Animal Hospital in North Huntingdon Pa, if Petland Norwin is unable to reach your listed veterinarian, or provide transportation to your veterinarian. If Petland Norwin deems that your pet is in need of emergency veterinarian care, Petland Norwin will present your pet at AVETS in Monroeville Pennsylvania. If your pet passes away while in the care of Petland Norwin it will be transported to the listed veterinarian, or St. Francis Animal Hospital. You will be fully responsible for all costs related to any medical treatment, including without limitation the cost of any transportation for any such treatment.
